CALL FOR SEED GRANT PROPOSAL MINOR RESEARCH PROJECT

The Research and Development (R&D) of the Marwadi University invites **proposals for seed grants**- **Minor Research Project** from dynamic and young researchers working as Permanent Faculty
Members of Marwadi University. This is in pursuance of the research policy envisioned by honorable
Provost for developing a culture of excellence in Research & Development. Proposals are invited
from faculty members of all academic departments of MU.

APPLICATION PROCEDURE

The application should be prepared strictly as per proforma mentioned in this call. The applicants should clearly state technical outcomes, impact on society and effect on student community.

A cover letter with a CV of Principal Investigator (PI) and Co-Principal Investigator (Co-PI) and detailed application in hard copy recommended by respective Dean/Principal (recommended by DRC of respective faculty) of the Faculty should reach to the Dean-Research, MU on or before 31/10/2022.

SELECTION PROCEDURE

The Research and Development (R&D) will scrutinize the proposal with the help of their respective (Department Research Committee) DRC in terms of technical & domain outcomes and impact on society in various domains. Although, areas for the proposal are not defined; it should be in line with the area of interest proposed by the respective department in its plan.

In case of multiple applications in the same domain and/or department, an opinion may be sought from the team of external experts. The final decision will be made based on recommendation of team of experts and University Research Council (URC) of MU.

ELIGIBILITY

The applicant shall be a permanent faculty member of MU and should have received Ph.D. degree not more than three years from a recognized university. However, relaxation to this effect may be accorded with due recommendation of Dean/Principal of the concerned Faculty.

ASSESSMENT CRITERIA

The relevance of proposal to call objectives need to be conclusively established. The proposal relevant to call objectives will be evaluated based on following criteria:

- a) Novelty of the proposed work,
- b) Need assessment and demand for proposed work,
- c) Scientific appropriateness of deliverable of proposed approaches and technical merit,



d) Proposal formulation. Literature/Patent review, Qualified objectives, Methodology and Work plan, clear and well-defined deliverable.

The weightage of above parameters will vary for different specializations.

TERMS AND CONDITIONS

- The application must be strictly as per the format mentioned in the policy document.
- The tenure of Minor Research Project will be maximum of two years. The maximum amount of Minor Research Project will be Rs. 2.50 lacs for the entire duration of the project
- The amount of assistance will be utilized towards procurement of Equipment or Consumables not exceeding Rs. 2.50 lacs. The purchase of PC, Laptop, Mobile, Electronic Gadgets, Software, and Mobile Applications etc. is not permitted under the grant.
- The amount for the second year will be disbursed only after satisfactory report of the first academic year.
- At the end of each financial year, utilization certificate from certified auditor must be produced by the Principal Investigator.
- All Equipment and Consumables purchased under the project will remain property of the
 respective department of MU. It is sole responsibility of PI and Co-PI to maintain the record
 equipment till completion of the project. At the end of project, the PI or Co-PI will submit
 status of equipment/consumables to the department.
- The PI or Co-PI are not entitled for remuneration, consultancy, travel, contingency or salaries of manpower for the Minor Research Project.
- The PI or Co-PI must not leave the institute before the completion of the project.
- At the end of completion of project, PI and Co-PI should publish one paper in Science Citation Index (SCI-indexed), ABDC, SCOPUS-indexed, Thomson Router listed journals after the peer-review or monograph, case study, book chapter, reputed journals recommended by Dean/Principal (to ensure quality of publication) of respective faculty or file a Patent based on the work carried out or equivalent outcome endorsed by the DRC with consent of Dean. The completion certificate will be issued only after acceptance of such an article.
