FlyWire Payment Instructions

To make a payment:

- Select the country from which your funds will be coming from and the payment amount (in Canadian dollars) you wish to make to Fanshawe College.

- After providing some basic information, you get 3 options to make payment to send funds from your local bank to FlyWire. 1) Domestics Bank Transfer 2) Mastercard and 3) Visa. The Canadian Dollar amount you mention is converted into INR amount.
- If you select Domestic Bank Transfer option and proceed, you will get 3 steps of instructions.
 The first step will be to pay the fee to the Yes Bank, India bank account details that you get. Step 2 provides instructions to print A2 form and Step 3 provide instructions to send the A2 form.
- Through the FlyWire student dashboard you will be able to track where your payment is in the transfer process.
- You will receive an email confirmation from FlyWire when your payment is deposited into the Fanshawe College bank account.
- FlyWire send you an official receipt with your student ID and the amount you have paid. This receipt should be used for the visa application.
